- Permanent education and professional evaluation of food to increase the awareness of the population in the production of safe and quality food, protection and management of the living and working environment and consumption of energy and water,
- Constantly maintaining a sense of responsibility and conveying all the requirements of the standards of quality, safe food, environment, energy, sustainability, safety, and health at work, to everyone and at all levels, through their consultation and participation, ensuring that it is active internal communication,
